Vote by Mail Voters may apply for a ballot in-person in the county clerk's office anytime up to 3 p.m. on the day before an election. Ballots issued over-the-counter may be taken directly to the Board of Elections on the first floor at 50 Rancocas Road to be voted and turned in.

Voters also have the option of returning their ballot by mail. Voted ballots must be received by the Board of Elections before polls close on the day of the election when delivered in person. A mailed ballot may be postmarked by Election Day and must be received by the Board of Elections within 48 hours to be counted.

- **Household Battery Recycling.** Do Not Recycle Alkaline Batteries, such as AA, C, D, or 9 Volt. Put them in your household trash. Rechargeable batteries come in the same sizes and are used for laptops and toys. Rechargeable batteries include Nickel Cadmium (Ni-Cd), Lithium Ion (Li-Ion) and Small Sealed Lead Acid (SSLA/Pb). Recycle these at Home Depot, Lowes, Staples and other locations listed at www.Call2Recycle.org. **Never put batteries in your recycling! Batteries have caused fires at recycling centers!**

Curfew. As the school semester ends please be advised of the Township Code regarding Curfews of juveniles, defined as individuals under the age of 18 years.

ROAD CONSTRUCTION American Asphalt will be performing work on Oxmead Road and Smithville Road beginning on or about the week of June 17th 2019. The work is projected to last until Friday, August 16, 2019. Eastampton Township Police officers will be in the area to assist motorists throughout the duration of this project. Expect delays during this time.

New Jersey American Water Important Message. New Jersey American Water will begin routine flushing of the water distribution system in your area Monday, June 03 thru Saturday, June 15 from 8:00 A.M. to 10:00 P.M. to ensure that you continue to receive high-quality water service. Flushing also allows us to monitor and maintain fire hydrants. When crews are working in your area, you may notice reduced pressure, cloudy and or discolored water. If your water is discolored, run the cold water only at the lowest level of the house for about 3 to 5 minutes so that it clears before using. Long-delayed Smithville Road Bridge expected to re-open next month

The 104-year-old bridge over the Rancocas Creek, next to Smithville Park, has been closed to traffic since January 2017 because of concrete deterioration. Work on a \$4.8 million replacement project began last year, but the project has suffered from multiple mistakes and delays.

EASTAMPTON —There's a new re-opening date for Smithville Road Bridge, which has been beset with delays and problems, including a recent one involving the spans guardrails.

The 104-year-old bridge over the Rancocas Creek, next to Historic Smithville Park, has been closed to traffic since January 2017 because of concrete deterioration. Work on a \$4.8 million replacement project began last year, but the project has suffered from multiple mistakes and delays. The tentative new reopening date is around June 15.

"It's been a comedy of errors. There's no other way to describe it," Freeholder Director Tom Pullino said about the bridge project and its problems and long delays.

County officials had originally anticipated work on the bridge would be finished last December, but the anticipated opening date was pushed back until March due to a flaw with the bridge design that wasn't discovered until the final stages of construction.

The project suffered more delays this spring involving the bridge railings, which county officials said had to be returned so that a coating of corrosive protection could be reapplied. The rails also had to be repainted because the color did not match the hue mandated by the State Historic Preservation Office, which contributed to the design of the bridge because of its historic significance.

The bridge deck is scheduled to be paved Tuesday and the new repainted railings are expected to be installed soon so the bridge can re-open on or around June 15, according to county spokesman Nicholas Gangemi said.

"The Smithville Bridge cannot be reopened without the railings as it provides essential crash protection for residents as they cross," Gangemi said. "The county engineering department is working diligently to open the bridge as soon as possible without compromising the quality of work."

The latest delay is not expected to increase the cost of the project, which is being funded through state and federal grants.

"The contractor is covering the cost overruns from soup to nuts," Gangemi said.

But in February the freeholders were forced to approve a \$628,273 change order in its construction contract to cover the additional expense related to the design flaw, which involved a retaining wall adjacent to the bridge that supports the roadway and a new 6-foot-wide sidewalk.

The design of the structural steel pilings on the wall did not accurately consider the soil conditions so the pilings ended up too shallow to support the new sidewalk and a guide rail.

The design mistake was made by Dewberry, an engineering firm that had been consulting on the project since 1999, said the county engineer's office. The firm was selected based on responses to a request for qualifications and proposal process directed by the Delaware Valley Regional Planning Commission, which is required to greenlight transportation projects in the county in order to make them eligible for federal funding.
