All of the paperwork for the NJ State Suppression System Survey on all Educational buildings has been completed and sent to the Division.

The Shilden Group Building at #1307 Woodlane Road has pressurized the system and it is now operational for fire suppression. They are still waiting for the dialer to be hooked up by the alarm company.
