**RESOLUTION 2020 – 8**

**FIXING THE SALARIES, WAGES, COMENSATION AND BENEFITS FOR  
OFFICIALS AND EMPLOYEES OF THE BOARD OF FIRE COMMISSIONERS FOR  
THE FISCAL YEAR 2020**

**WHEREAS**, the Board of Fire Commissioners of the Fire District No. 1, Township of Eastampton, County of Burlington, State of New Jersey has created certain paid positions within the District pursuant to and in accordance with N.J.S.A. 40A: 14-81.1; and

**WHEREAS**, the Board has established salaries, wages and compensation for said positions and the employees appointed thereto:

**NOW, THEREFORE, BE IT RESOLVED**, by the Commissioners of Fire District No. 1 of the Township of Eastampton, County of Burlington, State of New Jersey that it fix the salaries, wages and compensation, for services for said positions and to personnel employed in said positions for the fiscal year 2020 as follows:

Title Salary	Wage, Compensation and Benefits
Fire Official	\$20.25 per hour not to exceed \$7,450 per annum
Fire Inspector	\$15.00 per hour not to exceed \$7,450 per annum
Board Administrator	\$1,200.00 per month not to exceed \$14,400 per annum

**BE IT FURTHER RESOLVED**, that the salaries, wages and compensation set forth in this Resolution is the maximum compensation to be paid for various positions during 2020 and for such period or periods as this Resolution shall remain in effect;

**BE IT FURTHER RESOLVED**, such maximum salaries, wages and compensation shall be paid for each of the positions indicated unless the Board, by Resolution ,shall otherwise fix the salary, wages and compensation in which the event of such amount shall be paid;

**BE IT FURTHER RESOLVED**, that all compensation authorized by this Resolution Shall be paid commencing retroactive to January 1, 2020 through December 31, 2020;

**BE IT FURTHER RESOLVED**, that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid same shall not affect the remainder of this Resolution;

**BE IT FURTHER RESOLVED**, that any Resolution, or part of a Resolution inconsistent herewith are hereby repealed or otherwise revoked;

**BE IT FURTHER RESOLVED**, that an original signed, conformed and compared copy of this resolution be accessible and maintained as an official Board record pursuant to and in accordance with the “Open Public Records Act”; N.J.S.A. 47:1A-1, *et. seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
