COMMITTEE REPORT:

EDAC: Township Manager White provided that the owner next to the Police Department on the southeast corner of Woodlane Road wanted to proceed with a use variance and site plan application to have a mixed-use property with retail space and apartments. This conformed to the new Master Plan.

LUPB: Mr. Apgar expressed appreciation to the Eastampton Community School for use of the building for the reorganization meeting on January 17th. Mr. Adams was voted as the Chairman; Mr. Chieco was voted as the Vice-Chairman; and there was a 90-day continuance on the variance application for Rockefeller Acquisitions LLC.

Veteran's Committee: Mr. Rodriguez noted the board would have a meeting in February.

Recreation Committee: Mayor Santillo noted he would reach out to set up a meeting with the members.

DISCUSSION ITEMS:

- 1. Appointment of Council Liaisons to Certain Local Public Agencies This item will be on the February 12, 2024 agenda as a resolution.
- 2024 Goals of the Township Council
 Mayor Santillo and Township Council discussed the goals for 2024:
 Enhancement of Public Spaces
 - 1. Parks
 - a. Discussion on connecting Smithville Park to existing walking/biking networks; Knightsbridge Road or Powell Road to Smithville Road.
 - b. Township Manager White was questioned on what was happening with Veteran's Park and responded we would apply for further funds with the next Municipal Aid grant.
 - 2. Public Facilities
 - a. The Veteran's Park signs were still outstanding, and a picnic table (or two) in the pavilion would be a nice addition.
 - 3. Public Grounds
 - a. Discussion on adding landscaping around the Veteran's Park pavilion, to be built up over time.
 - b. Replace garbage cans at Buttonwood Park to heavier cans that do not tip over.
 - c. Enhance walking/biking areas, with benches along walking paths.

3. DCA Local Recreation Improvement Grant Enhance Hollyville Park with 2nd component: parking lot. Ask for contingency to also include park entrance sign.

STAFF AND PROFESSIONAL COMMENTS:

Township Attorney Marmero discussed the Governor's liquor license law reform.

- 1. Municipalities with Shopping Malls- we do not have any in our Township.
- 2. Transfer of Inactive Licenses- speeds up the process after 2 years license has not been used; license transferred to another town. We do not have any in our Township.
- 3. Breweries, Cideries, Meaderies, and Distilleries- there are currently none in our Township, but we may have some in the future.
- 4. Farm-Brewery License- newly established license issued only when the brewery is located and constructed on a tract of land exclusively under the license holder's control, and is actively engaged in farming on or adjacent to the brewery premises.

Township Manager White commented on the fantastic job the Public Works Department did during the snow event over the weekend. Public Works Director Fred Rodi came in on Saturday and kept Ms. White informed, and the entire department worked excellently.

Mayor Santillo replied that the Public Works Department did a great job.

PUBLIC COMMENT:

Eddie Besko remarked that the Public Works Department did a great job in the developments, and the plows came in nice and close to the curbs for the residents.

It was MOVED by APGAR and seconded by ZENO to adjourn the meeting at 8:13 pm.
