ORDINANCE 2023-14 TOWNSHIP OF EASTAMPTON BURLNGTON COUNTY

AN ORDINANCE OF THE TOWNSHIP OF EASTAMPTON TO AMEND CHAPTER 510 OF THE TOWNSHIP CODE TO ADDRESS STANDARDS FOR VEHICLES AND TRAFFIC

WHEREAS, the Township recognizes the need to continually address standards for vehicles and traffic, especially in light of recent development within the Township; and

WHEREAS, the Township finds it to the be in the best interest of the safety of the residents of Eastampton Township to readdress certain standards for vehicles and traffic; and

NOW THEREFORE, BE IT ORDAINED by the Township Council of the Township of Eastampton, County of Burlington, State of New Jersey as follows:

SECTION 1. Section 510-37 of the Township Code of Eastampton shall be amended as follows:

The following shall be added: (Language in **boldface** is added)

Parking permitted in designated areas only

(Follow posted signage)

SECTION 2. Section 510-56 of the Township Code of Eastampton shall be amended as follows:

The following shall be removed:

Name of Street

Location

Smithville Road (County Route 684)

Intersection of Monmouth Road (County Route

537 northbound

SECTION 3. Section 510-58 of the Township Code of Eastampton shall be amended as follows:

The following shall be added:

PARKING IN FRONT OF MAILBOXES PROHIBITED

No person shall park a motor vehicle on a public street so as to block any residential or public U.S. Postal Service mailbox.

SECTION 4. Repealer. All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.

SECTION 5. Severability. If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The governing body of the Township of Eastampton declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

SECTION 6. Effective Date. The ordinance shall take effect immediately upon passage and publication according to law.
