**ORDINANCE 2024-3
TOWNSHIP OF EASTAMPTON
BURLINGTON COUNTY**

**AN ORDINANCE TO AMEND SECTION 250-5(B) OF THE TOWNSHIP CODE
REGARDING ANNUAL REGISTRATION FEES FOR NON-LIFE HAZARD USES**

WHEREAS, the Township recognizes the need to continually review and update fees for the provision of Township services; and

WHEREAS, the Township recognizes that as it is taking over duties as the Local Enforcing Agency, now is the appropriate time to address annual registration fees for non-life hazard uses; and

NOW THEREFORE, BE IT ORDAINED by the Township Council of the Township of Eastampton, County of Burlington, State of New Jersey as follows:

SECTION 1. Section 250-5(B) of the Township Code of Eastampton shall be amended to now read as follows: (Removed language has a ~~striketrough~~, new language is in **boldface**)

Fees. For each type listed above, the annual fee shall be as follows, based on building size:

- ~~(1) Five hundred square feet to 1,000 square feet: \$42.~~
- ~~(2) One thousand square feet to 5,000 square feet: \$72.~~
- ~~(3) Five thousand square feet to 10,000 square feet: \$132.~~
- ~~(4) Over 10,000 square feet: \$192.~~

Area (square feet)

- (1) 0 to 1,500: \$85**
- (2) 1,501 to 2,499: \$115**
- (3) 2,500 to 3,499: \$150**
- (4) 3,500 to 4,499: \$210**

SECTION 2. Repealer. All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.


SECTION 3. Severability. If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not effect the remaining provisions of this ordinance. The governing body of the Township of Eastampton declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

SECTION 4. Effective Date. The ordinance shall take effect immediately upon passage and publication according to law.
