TOWNSHIP OF EASTAMPTON BURLINGTON COUNTY

AN ORDINANCE TO AMEND THE EASTAMPTON TOWNSHIP CODE AT CHAPTER 444, "RECEPTACLES" TO AMEND THE TYPE OF ACCEPTABLE RECEPTACLES WITH SOLID WASTE COLLECTION

BE IT ORDAINED, by the Township Council of the Township of Eastampton, in the County of Burlington and State of New Jersey as follows:

SECTION I

Section 444-1 Definitions; Container. Container to be approved by the Township Manager.

Section 444-3 of the Township Code entitled "Receptacles" is hereby amended to add the type of acceptable receptacles "Duty to provide. Residential refuse and garbage shall only be placed in the containers provided by the Township or in containers that have been approved by the Township Manager. The Township will only be liable for repairs or replacement for containers that were provided by the Township.

Section 444-4(A) Specifications. For the purposes of this section, "suitable" shall be defined as a container approved by the Township Manager for collection of residential refuse and garbage.

Section 444-4(C) Damaged Containers applies only to the containers that the Township provided.

SECTION II

Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

SECTION III.

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.

SECTION IV

All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.
